- 8. The Financial Bid of the prospective qualified Bidder will be considered only if the Technical Bid of the Bidder(s) is found qualified by WBGEDCL. The decision of the WBGEDCL will be final and binding on all concerned and no challenge against such decision will be entertained. The name of qualified Bidders will be displayed in the website before opening of the Financial Bid
- 9. Bids will remain valid for a period not less than 180 (One Hundred Eighty) days from the date of opening of Financial Bid. However it may be extended in case of exigencies with consent from the successful bidder(s)
- 10. The offer prepared by the Bidder and all correspondence and documents relating to the Bid exchanged by the Bidder and the purchaser will be written in English. The desired documents and any other document uploaded by the Bidder will be written in English.
- 11. The Bidder will be deemed to have carefully examined the Tender Document also to have been satisfied himself as to the nature and character of the system to be supplied and installed against the contract, and all relevant matters & details. Clarification if any will be considered only if pointed out by the firm in the Pre Bid meeting
- 12. This Bid is a No Deviation Bid. Request for any deviation may be considered only if pointed out by any prospective Bidder(s) in the Pre Bid meeting. No deviation will only be considered with the bid.
- 13. Technical Bid and Financial Bid both will be submitted concurrently duly digitally signed in the Website <a href="https://wbtenders.gov.in under WBREDA tenders">https://wbtenders.gov.in under WBREDA tenders</a> within the time as specified above.
- 14. The intending tenders should clearly understand that whatever may be the outcome of the present invitation of Bids, no cost of bidding will be reimbursable by WBGEDCL. WBGEDCL, however, reserves the right to reject any or all the bid(s) without assigning any reason whatsoever at any time prior to the award of Contract and is not liable for any cost that might have been incurred by any Bidder at the stage of bidding process. - 15. Blacklisted and / or with debarring actions as on date due to any reason what-so-ever, by any Government or Government Agencies will not be allowed to bid. - 17. If the offer is submitted without or inadequate Earnest Money, the bid will not be opened.
- 18. The intending Bidders are required to submit their offer online only. No offline Bid will be entertained and accepted.

- 19. The eligibility of bidder has already been stipulated. The bidders will have to meet the minimum criteria as per NIeT. The eligibility will be ascertained on the basis of the document(s) submitted in support of minimum eligibility criteria.
- 20. Submission of false document is strictly prohibited and if found action may be taken by referring to the appropriate authority for prosecution as per relevant Act with forfeiture of earnest money forthwith. - 24. Before issuance of the WORK ORDER, WBGEDCL will verify the credential(s) and/or other document(s) of the lowest bidder. After verification, if it is found that the document(s) submitted by the lowest bidder is/are not in order the bid will be cancelled and no work order will be issued in favour of the said bidder and the EMD will forfeited.
- 25. If any discrepancy arises between two similar clauses on different notifications, the applicable clause will be solely as per the decision of the WBGEDCL.
- 26. If the dates of opening of Technical Bid and Financial Bid fall on holidays or on days of strike or natural calamity, the dates get deferred to next working days.
- 27. All Bidders are requested to be present online during opening of Bids positively. In no case his/her absence will stand against opening of bids.
- 28. Conditional / incomplete Bid will not be entertained.
- 29. Any evidence of unfair Trade Practices including over charging, price fixing, cartel etc. as defined in various statutes, will automatically disqualify the bidders.
- 30. Work order / site clearance may be issued in phase manner/ batch wise. Intending Bidders may consider these criteria while quoting their rates.
- 31. If any Bidder withdraws his offer after opening of bid without giving any satisfactory explanation for such withdrawals, the EMD submitted by the bidder will be forfeited and the bidder will be debarred from taking parts in the next three subsequent tenders of WBGEDCL.

33. When the time of completion of the whole work is the essence of the project, WBGEDCL may distribute the whole work amongst more than one acceptable bidder who would subsequently agree to accept the lowest acceptable price without compromising the quality of the whole work and altering the original terms and conditions of the tender.
