Contractor will submit an amount of Rs. 9,000.00 (Nine thousand only) as EMD in the form of Demand draft/Pay order drawn in favour of "West Bengal Green Energy Development Corporation Ltd" from any Bank payable at Kolkata in the form of bank draft/ banker cheque. 
