Payment shall however be made as per actual execution of work.

10.0 The successful bidder have to be submitted Additional Security Performance @ 10% of the tendered value, if the bid value is 80% or less of the estimated Cost put to the tender.


15.0 If the offer is submitted without or inadequate Earnest Money (Bid Security), the bid will not be opened. Incomplete offer will be liable for rejection.
